

Event Form for the East Devon Pebblebed Heaths(Woodbury Common)

The Pebblebed heaths are amongst the most important conservation sites in Europe due to the rarity of the habitats and species supported. The main core of the Pebblebed heaths are notified as a **Site of Special Scientific Interest (SSSI)**, a **Special Protection Area (SAC)** and a **Special Protection Area (SPA)**. Although designated as Common land and Open Access, under the Countryside and Rights of Way Act (CRoW) 2000, all organised and commercial events must apply for a license from the owners Clinton Devon Estates and the site manager, the East Devon Pebblebed Heaths Conservation Trust. We are generally supportive of all reasonable and non-damaging events and encourage recreational use of the Heaths.

Should you wish to organise an event on Woodbury Common please complete and return the form below. This will ensure your event is legal, that it will not clash with other existing events, and that it will not undermine the protected status of the site.

The Estate has a policy for all organised events that 10% of net income is donated to the Pebblebed Heaths Conservation Trust to support their conservation and access work. This ensures that the Heaths are available for all to enjoy. Please note that vehicles are not permitted on the Commons except in exceptional circumstances.
